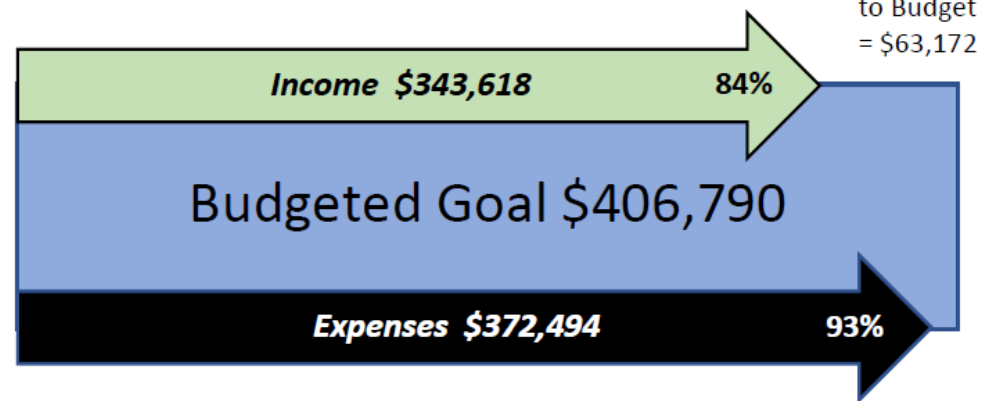
### 2018 DONATIONS
